## Problem

As a young firm, we needed to get a gauge on how our clients felt about out services, and the quality of the experiences they had with Legalite

#### Do we get access to our client feedback?

Yes. The point of this survey is primarily to get feedback from your clients so you can run a better business. Good, Bad or Ugly, feedback from your clients will help to keep your business sustainable and fresh.

Every firm who applies will be given a dashboard login through which they can track their respondents in real time. During the survey, your administrator will have full visibility on how many respondents you have had, and who has responded (unless they choose to remain anonymous). After the Awards have been announced, you will be given full access to all of your results in interactive, exportable tables and charts.

#### What are the awards categories?

Awards will be given for each of the Accountancy, Law, Bookkeeping and Conveyancing. Awards will be given in both Regional (State-based) and National categories.

For both Law and Accountancy, there are two size categories:

- Small: Annual Revenue <\$10m
- Mid-sized: Annual Revenue ≥ \$10m

Other categories will be dependent upon the volume and distribution of entrants. You will automatically be assigned a category on the basis of your firm's size, location and areas of expertise.

## Who can apply?

Accredited law, accountancy, conveyancing and bookkeeping practices with annual revenue under \$30m are eligible to apply. If your firm operates within a franchise or network of firms, each practice within the network is encouraged, but not required, to apply separately. If you decided to enter as one firm, your revenue must not have exceeded \$30m in the 2018 Financial Year.

#### How is the research done?

You drive the research. Your firm will be provided with a log in to your private, secure portal, from which you can invite clients in just one click, remind clients who haven't completed the survey to complete it in just one click, and visualise all of your feedback on your personalised, private dashboard.

#### Is there a minimum sample size?

Sample size requirements are dynamic and depend upon the categories for which you are eligible. Your firm will be significantly more likely to win if it has over 30 respondents in a particular category.

#### Can we submit separate entries for different office locations or categories?

Yes, but this is not compulsory and its will depend upon the particular circumstances of your firm. We recommend separate entries if your offices have separate databases, or if they are managed separately, as it may assist you in getting a broader and deeper cross section of feedback.

### What if we are a part of a franchise or network?

If your firm is part of a franchise or network of firms, you must submit an application for each office.
